Kindergarten Excursion Information: Amazement Farm

Dear parent or caregiver,

Students of KM and KO will be participating in an excursion to Amazement Farm, Wyong Creek on Thursday 14 September 2022. This excursion has been planned to supplement work being completed in the Key Learning Area of Science.

Students will experience wildlife and farm animal presentations and baby animal feeding led by trained guides. The content of the tour focuses on information about the needs of farm and native animals. Students will also participate in a train ride around the farm.

The cost for the excursion is \$35.00. This includes farm admission, farm train ride and bus trip.

DEADLINE FOR FINAL PAYMENT: Friday 26 August 2022. No payments will be accepted after this date.

Students are required to arrive at school at the normal time of 8.55am. Travel will be by bus and departing promptly by 9.30am. We will not be able to wait for any late arrivals. We will return to Wyoming Public School at approximately 2.30pm so that students can follow their normal afternoon travel arrangements home. Accompanying classroom teachers are: Emily Marsh and Megan O'Riley plus additional support staff.

Representing Wyoming Public School at an out of school event is a privilege for students who follow the school Welfare and Discipline Policy. Any student who does not follow this policy will be withdrawn at the discretion of the Principal and Executive Team. As a general rule, this will include any student who receives 2 or more detentions, a suspension or any incident involving aggressive behaviour during the term.
