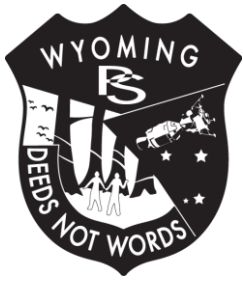

Privacy Advice
