Incursion Information – Water Play

Dear parent or caregiver,

Students who have registered 40 nights home reading on their log can engage in a water play incursion at Wyoming Public School on Wednesday 5 April 2023.

This incursion has been planned as a reward day to celebrate our students' involvement in home reading.

The students will be supervised by their class teachers and support staff throughout the event.

The staff member with CPR (Cardiopulmonary Resuscitation) training who will be in attendance is Matthew Walter.

Students will need the following items on this incursion:

- swimmers, rash vest, (goggles are optional)
- sun screen lotion
- towel and plastic bag
- change of clothing
- snacks, lunch, and drink to be brought from home / or lunch ordered from canteen.

The incursion will involve the following swimming or water activities; sponge tip, slip n slide, sponge catches and water blaster.

These activities will take place at school on the grassed area.

Incursion Consent Form – Water Play

My child has the following special or medical needs (please provide full details)

I understand that my child will receive medical treatment in the case of an emergency. I understand that when a medical practitioner has prescribed medication (including emergency medication) that will need to be administered during the excursion, parents are responsible for:

- bringing this need to the attention of the school
- ensuring that the information is updated if it changes
- supplying the medication and any 'consumables' necessary for its administration in a timely way
- any medication should be well within its expiry date and correctly labelled
- collaborating with the school in working out arrangements for the supply and administration of the prescribed medication for the duration of the excursion
- for some excursions, the school will ask parents to supply the medication in a unique way to what has already been agreed to by school. For example, parents may be asked to supply an additional adrenaline injector.

Important information

In the event of injury, no personal injury insurance cover is provided by the NSW Departmentof Education for students in relation to school sporting activities, physical education lessons or any other school activity. The Department's public liability cover is fault-based and limitedto breaches by the Department of its duty of care to students that may result in claims for compensation.

Parents/Carers are advised to assess the level and extent of their child/ward's involvementinthe sport program offered by the school, school sport zone, region and state school sport associations when deciding whether additional insurance cover is required prior to their child's involvement in the program. Personal accident insurance cover is available through normal retail outlets.

Parents/Carers who have private ambulance cover need to check whether that cover extendstointerstate travel and make additional arrangements as considered appropriate.

The NSW Supplementary Sporting Injury Benefits Scheme, funded by the NSW Government, provides limited cover for serious injury resulting in the permanent loss of a prescribed facultyor the loss of use of certain prescribed parts of the body. The Supplementary Scheme does not cover medical costs or dental costs. Concussion Clearance

The Australian Medical Association recommends students being symptom-free of concussionfor 14 days before returning to sport. Students who have suffered a concussion within 14 daysof the event, must provide written clearance from a medical practitioner prior participating.

 If your child/ward sustains a concussion, or experiences any concussion symptoms, inthe 14 days period prior to the event commencing, you must report this to team officials, and a medical clearance is required in order for your child/ward to participate in the event.

- Medical clearances can be attached to this consent form or can be submitted to teamofficials separately.
- I can confirm that I understand that, in the event of injury, no personal injury insurance cover is provided by the NSW Department of Education for students in relation to school sporting activities, physical education lessons or any other school activity. (Personal injury statement)
- I acknowledge that if my child/ward sustains a concussion, or experiences any concussion symptoms, in the 14-day period prior to the event commencing, I am required to report this to team officials. I further acknowledge that, should this occur, my child/ward will only be permitted to participate in the event, if a medical clearance is provided. (Concussion statement)

Ambulance / medical treatment

- I affirm that, to the best of my knowledge, my child/ward has no medical condition or injury that places him/her at risk by participating in this sport activity.
- In the event of any accident or illness, I authorise the obtaining, on my behalf, of an ambulance and any such medical assistance that my child/ward my require. I acceptfull responsibility for expenses incurred.

Privacy Advice
